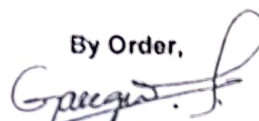

6. That If any changes in name of the society and members of the Governing Body of the Society of the concerned college should be informed to the State Government and SRC, NCTE, Bangalore without any delay.
7. That if any change of address of the college / Institution, the management should obtain permission from SRC, NCTE, Bangalore duly paying prescribed fee to the SRC, NCTE, Bangalore and the same should be informed to the office.

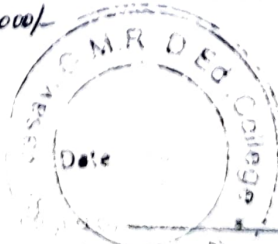
